# **Educational Objectives**

- Describe the most important diagnostic clues in arriving at a specific diagnosis in the most common patterns seen in soft rissue tumor.
- Develop an understanding of the characteristic histologic features that allow clear separation of the acute and chronic hepatitis patterns.
- Develop an understanding of the normal histology of the intrahepatic biliary system and how it is affected by a
  variety of cholestatic liver diseases.
- Develop an understanding of the utility of clinical history and laboratory findings in averting misinterpretation of histologic findings in medical liver biopsies.
- · Learn and apply diagnostic criteria for difficult benign melanocytic neoplasms.
- · Learn and apply diagnostic criteria for epithelioid and spindled vascular neoplasms.
- Develop an approach to common and important inflammatory diseases encountered by practicing surgical pathologists.
- Understand and apply the most recent International Society of Urologic Pathology/2016 WHO Gleason grading guidelines for prostate cancer.
- · Be aware of and be able to diagnose newly recognized tumors of the kidney.
- Understand the importance of key pathologic parameters in the management of patients with T1 bladder cancer.
- Utilize the WHO terminology and histologic and molecular features for a variety of mesenchymal gynecologic tumors.
- Recognize the features that distinguish borderline ovarian tumors from carcinoma.
- Assess hormonally treated endometrial carcinomas and predict responsiveness to treatment.
- Become familiar with the rationale for and updated methods of endoscopic surveillance in inflammatory bowel disease, including the epidemiology of cancer risk.
- Become knowledgeable of the spectrum of gluten-related disorders and current optimum testing for celiac disease.
- Learn the updated epidemiology of cancer risk and Barrett esophagus and the current data on the efficacy of endoscopic surveillance.
