About The Meeting

This symposium is structured as a practical, clinically oriented review of recent advances in OB-GYN ultrasound. A mix of topics including comprehensive gynecological imaging and detailed evaluation of normal fetal anatomy along with abnormalities of fetal major organ systems will be discussed. In keeping with progress in this field, detailed information on the use of three-dimensional ultrasound and fetal imaging in the early gestation is presented. Guidelines and indications for OB-GYN ultrasounds are reviewed in-depth so registrants can expand their clinical practices. Tips, images, and pitfalls provide balance to the program.
